THIS DEED, made and entered into this 25th day of August, 1993, by and between Charles B. Deane, Jr. and William R. Webb, Jr., acting as Co-Commissioners as hereinafter stated, parties of the first part; and The Bob Swann Co. Inc., of Montgomery County, North Carolina, party of the second part;

WITNESS ETH:

THAT WHEREAS, in a certain special proceeding entitled Helen Gibson, Petitioner vs. Joanna Wall, Helen Gibson, Johnsie L. Lindsey, Wilhelminia Lindsey Bibbs, Crawford L. Wall and wife, Agnora Wall, Effie Lindsey, and all other known and unknown heirs of Helen J. Wall, Respondents, brought and pending before the Clerk of the Superior Court of Richmond County, North Carolina, an order was made by said court appointing said parties of the first part as Co-Commissioners to sell at public sale, subject to the confirmation of the court, certain lands hereinafter described; and whereas, said parties of the first part, acting as Co-Commissioners as aforesaid, after due advertisement as required by law and said order of court, offered said lands for sale at public auction at the courthouse door as directed by said order, at Il o'clock, A.
