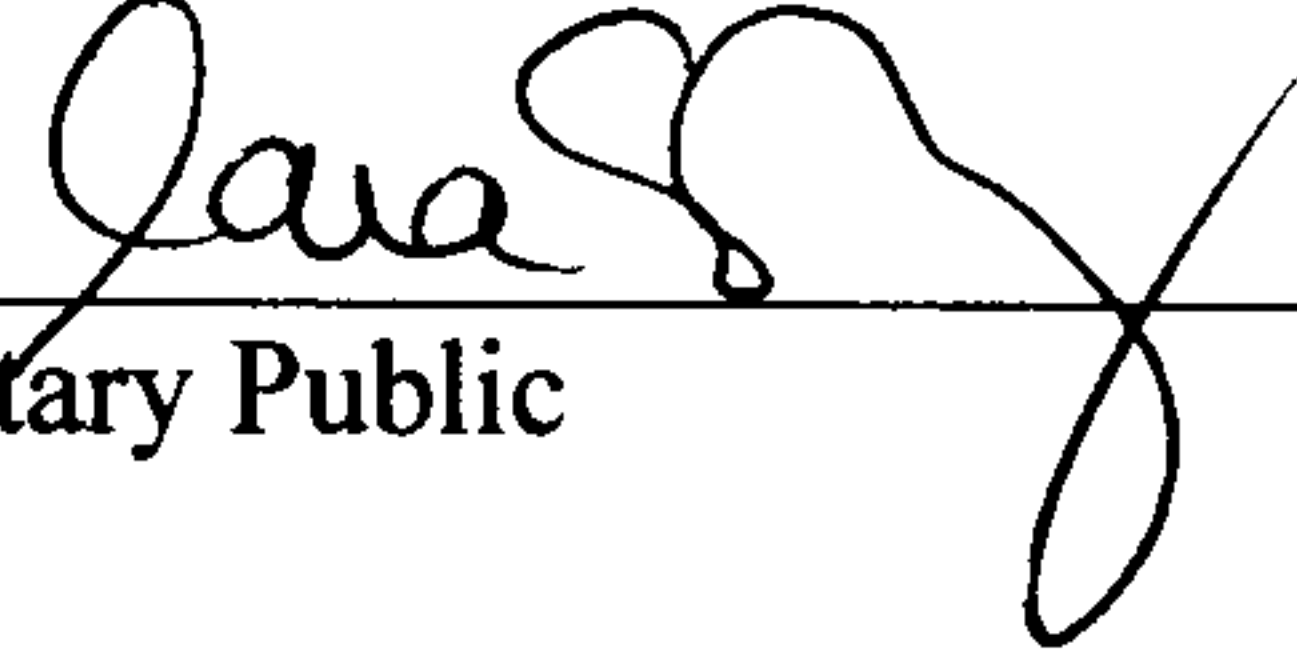

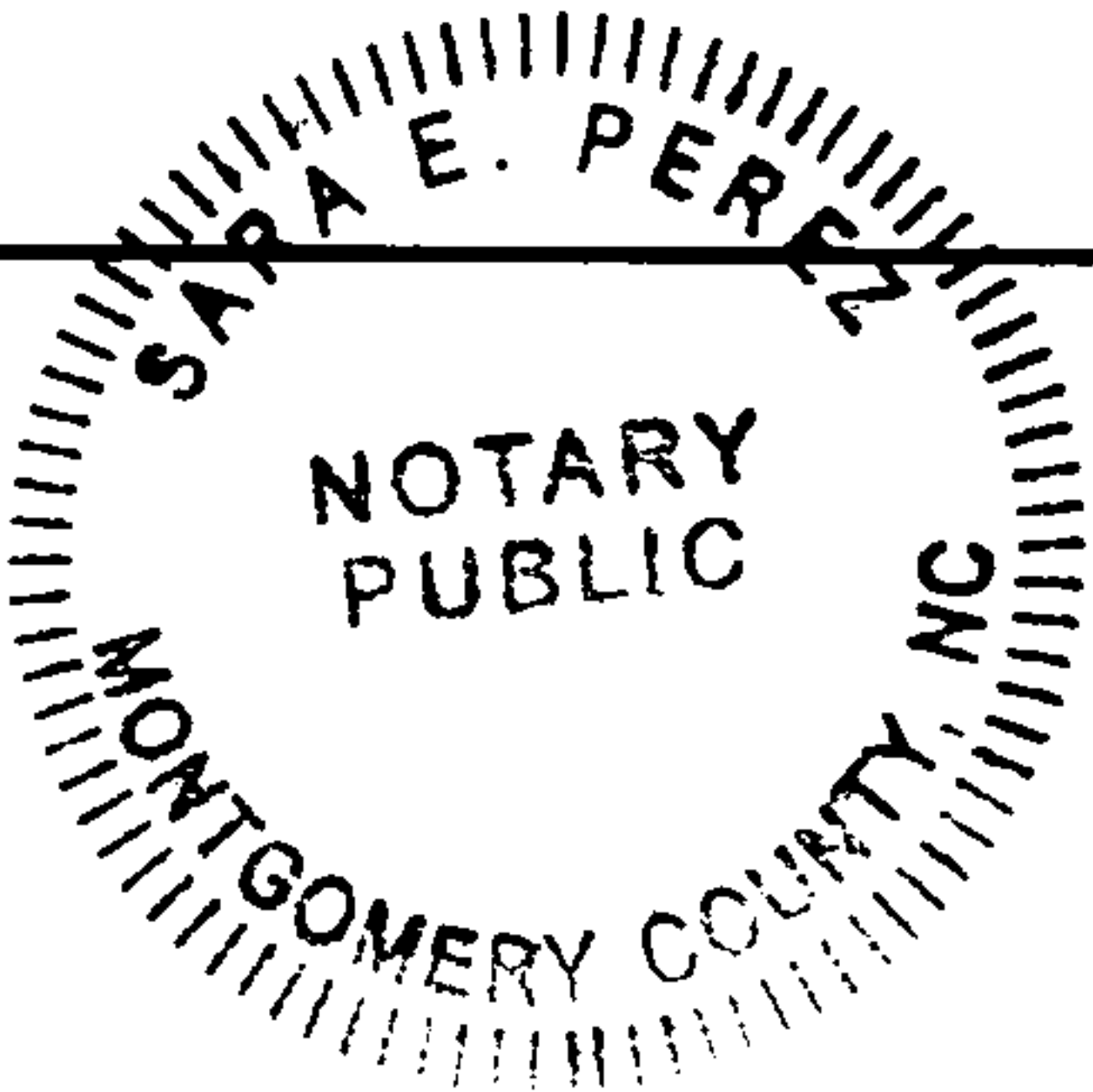

## ⑧ ALLEN-MANESS LUMBER CO. TRACT

BEGINNING at an iron stake in the northeastern edge of the said sand clay road leading south-eastwardly from Wadeville, North Carolina, Hattie Fesperman southeastern corner, said beginning - corner being situate N. 55-08 W. 9.35 chains and N. 50-00 W. 11.33 chains along said road from a point in the center of said sand clay road where it crosses a small branch over a culvert and from said beginning corner runs with Hattie Fesperman's line N. 26-45 E. 17.77 chains to an iron stake, Hattie Fesperman's corner; thence S. 86-30 E. 1.43 chains to an iron stake; thence S. 7-30 E. 26.63 chains to an iron stake in the center of said road; thence with the center of said road N. 55-08 W. 5.00 chains to a corner; thence along said road N. 50-00 W. 11.32 chains to the beginning, containing 16.00 acres more or less as surveyed by J. S. McNeill, Registered Surveyor in 1957, plat of which said survey has been filed for record and recorded in the office of the Register of Deeds for Montgomery County, North Carolina in Plat Book 3 at page 100 and being the first tract of land described in deed from Allen-Maness Lumber Company to Norman Lumber Company dated November 24, 1950 and recorded December 11, 1950 in the office of the Register of Deeds for Montgomery County, North Carolina in Book 99, at page 197.
