Reference may be made to a deed from Rutha Hodgkins to Rutha Hodgkins and David Larry Hodgkins dated December 21, 1992, and recorded in the Oxford County Registry of Deeds in Book 1968, Page 257. Rutha Hodgkins died on December 22, 2006, leaving David L. Hodgkins as sole surviving joint tenant.
